<u>CALL TO ORDER.</u> The Hubbard Planning Commission meeting was called to order at 6:33 p.m. by the Planning Commission Chairman Anthony San Filippo virtually via ZOOM because of the COVID - 19 virus.

## APPROVAL OF THE JULY 21, 2020, PLANNING COMMISSION MEETING MINUTES.

MSA/Planning Commissioner Scott Stierle / Planning Commissioner Nik Kulikov moved to approve the minutes from the July 21, 2020, meeting. Planning Commission Chairman Anthony San Filippo, Planning Commissioner Nik Kulikov and Planning Commissioner Jessica Countryman were in favor. Motion passed unanimously.

MODIFICATION to Site Development Review # DR 2020-01 – 3490 3<sup>rd</sup> Street (Tax Lot 041W33AD07600) – Matt Kennedy. City Planner Holly Byram summarized the Staff report that was provided in the packet. She stated the applicant received Planning Commission approval in April for concurrent land use applications, and now the applicant needs to make modifications to the size of the building that was approved on file #DR 2020-01. City Planner Holly Byram said that a 900 square foot building was approved, but now the applicant has a likely tenant and needs to increase the size of the building to 1242 square feet. She went on to say typically under the Hubbard Development Code you can do that up to 25% without any land use review, but this is a 38% increase in size, so it needs to come before the Planning Commission. H. Byram stated there does not need to be a public hearing on it, but neighbors do need to be able to comment on it, so a letter was sent out with a 14- day comment period, but we did not receive any feedback.

City Planner Holly Byram said typically when increasing the size of a building the red flags that go off are parking and storm water, but neither of these are an issue, the applicants storm water plan can handle the increase, and the applicant has enough parking to accommodate the increase in size.

Matt Kennedy said he put in a new curb instead of patching the old one, and the site will be fully developed in the weeks to come. He stated Marion County is holding the permit for the building and he hopes to have the foundation in the ground in 3 or 4 weeks. He stated he is hoping for an opening in the Spring of the new Café.

MSA/Planning Commissioner Scott Stierle /Planning Commissioner Jessica Countryman made a motion to approve the requested modifications to approved development site plan for file #DR 2020-01 and adopt the findings and conditions contained in the Staff Report. Planning Commissioners Scott Stierle, Planning Commissioner Chairman Anthony San Filippo, Planning Commissioner Nik Kulikov and Planning Commissioner Jessica Countryman were in favor. Motion passed unanimously.
